- Admissions must be purchased online NO cash sales at the door.
- Wristbands will be provided and must be worn on your wrist at all times.

TEAM CHECK-IN

Teams need to submit and finalize their roster within AES by FRIDAY, OCT 17.

Online Team Check-In will open at 12 A.M. October 26 and close at 12 P.M. October 29

- Teams will need to <u>check-in online before their arrival</u> to verify that their roster is complete.
- Club Directors with AES account access are the ONLY people that can check in teams online.

TEAM ELIGIBILITY

2025-2026 AAU Indoor Boys Volleyball Age Divisions

Age Definitions:

Team members must meet the age definitions for their age group.

18 and Under - Players who were born on or after July 1, 2007 **OR** Players who were born on or after July 1, 2006 **and** a high school student in the twelfth (12th) grade or below during some part of the current academic year are eligible to compete on 18 and under teams.

17 and Under – Players who were born on or after July 1, 2008

16 and Under – Players who were born on or after July 1, 2009

15 and Under – Players who were born on or after July 1, 2010

14 and Under – Players who were born on or after July 1, 2011

13 and Under – Players who were born on or after July 1, 2012

12 and Under – Players who were born on or after July 1, 2013

11 and Under – Players who were born on or after July 1, 2014

10 and Under – Players who were born on or after July 1, 2015

REGISTRATION, DIVISIONS, AND PLAYING WAVES

Tournament Registration:

The entry fee for the tournament is \$875 per team. JVA members receive a reduced registration fee of \$850. Refunds will be given, less 25% up until Friday, October 3. No refund will be given thereafter for teams that withdraw. If the Chi-Town Boys Challenge is cancelled by JVA/AAU, teams may receive up to a full refund at their discretion.

Gameplay Locations:

There will be three playing halls within McCormick Place:

- West Building
- Skyline Ballroom (located in West Building)
- North Building Halls C1/C2

Divisions of Competition:

Competition will be offered in 4 divisions, highest to lowest; OPEN, PREMIER, ELITE, CLASSIC

- 12s
- 13 Open, Classic
- 14 Open, Premier, Classic
- 15-18 Open, Premier, Elite, Classic

Playing Waves:

- AM Wave (8 A.M. start time)
 - 18s, 16 Open, 16 Premier, 16 Classic, 14 Open, 14 Classic, 13 Classic
- PM Wave (2:30 P.M. start time)
 - 17s, 16 Elite, 15s, 14 Premier, 13 Open, & 12s

SEEDING AND SCHEDULES

Seeding, Schedule, and Results:

Teams will be seeded by a JVA/AAU committee, which may vary by event. Schedules will be posted on AES approximately one week prior.

Pool play will take place on Saturday and Sunday; bracket play is on Monday, concluding by 6:00 P.M. Teams traveling from Chicago are advised not to schedule Monday flights before 6:00 P.M.

Live schedules and results will be available through AES.

RULES OF PLAY

JVA/AAU follows the <u>2023-2025 USAV Indoor Domestic</u> <u>Competition Regulations</u>.

Match Format/Warm-Up Procedures

- All divisions will play best of three set formats. Divisions that have 3-team pool(s) with no cross over match in combination with 4 team pools in the same division will play all 3 sets to 25. Pool finish will be based on set percentage as all 3 sets will count for finish placement. 3-team pools are not our recommended format and we will do everything we can do to avoid them. However, there are times where it is completely unavoidable.
- All crossover and challenge matches will be "match play" best of 3 sets.
- All warm-ups will be 2-4-4 (2 min shared ball handling, first 4 min court time for serving team, and last 4 min court time for receiving team). Teams must serve within their court time. The team off the court should assist in ball shagging during the on-court teams' warm-up.
- A new libero can be designated before each set.

Officials and Team Officiating Responsibilities

- The Head Official will schedule a First Referee (R1) for each match
- Work teams will need to provide a rostered adult as Second Referee (R2), Official Scorer, Libero Tracker and 2 Line Judges. An adult on the official roster needs to be court side at all times.
- The work team needs to report to the Head Official no later than the beginning of the serving team's warm-up. For each minute the work team is late or incomplete, one point will be given to their next opponent (up to 25-0 for forfeit).
- Each work team must have an adult present and identified to the R1 during a team's work assignment.

Pre-Match Protocol (All Non-Gold Finals):

Prior to the start of the 1st set, both full teams will line up behind the service line. At the signal of the head official, both teams will wave to each other and spectators. The starting line up will remain on the court for the lineup check, and the libero shall be waived in by the head official.

Ties in Pool Play - DO NOT LEAVE YOUR COURT AREA UNTIL YOUR POOL HAS BEEN DECIDED!

TWO WAY TIE:

- The result of their head-to-head pool match will determine the winner in ALL CASES.
- There will be NO PLAYOFF regardless of whether it affects the GOLD.

THREE-WAY TIES (Teams advancing to GOLD):

- Head-to-head results are used to determine pool finishes for teams that are tied in Match record.
 - A team that beats all other teams with which it is tied in Match Record will finish ahead of the other teams in the pool.
 - If there are only two teams tied in matches, the head-to-head winner of those 2 teams earns the higher pool finish.
- Set percentage is the 2nd level of breaking ties and is used to rank a pool in which all three teams remain tied after applying the rules in step 1.
 - Teams with a higher set percentage finish ahead of teams with a lower set percentage.
 - If only two teams are tied in both match and set percentage, the team that won head-to-head receives the higher finish in the pool.
 - Three-way tie for first place: If after steps 1 and 2, all three teams are still tied in match AND set percentage, the three teams will be seeded by points. The highest seed as determined by points, advances automatically. The highest seed will ref one set to 15 between the two lower seeds. The winner of this set takes the second spot in gold.

 Three-way tie for second place: If after steps 1 and 2, all three teams are still tied in match and set percentage, the three teams will be seeded by points. The highest seed will ref one set to 15 between the two lower seeds. The loser of the first set will ref one set to 15 between the winner of set 1 and the top seed. The winner of this set takes the second spot in gold.

THREE-WAY TIES (NO teams advancing to GOLD):

 If a tie occurs and no teams are able to advance to GOLD. Steps one and two from the above criteria will be used. In the case teams are still tied in matches and sets. Point differential will now be used to decide the pool.
 NO PLAY-OFF match will be played.

Code of Conduct/Disciplinary Action:

Any participant listed on the official roster who is causing unfavorable situations either prior to, during, or after the event is subject to disciplinary action by the Tournament Director(s). Anyone discovered in possession of or consuming illegal drugs, alcohol, tobacco products, or e-cigarettes (vaporizers) will be immediately expelled from the event. There are no warnings for possession or consumption of materials listed above for players or any other underage person whose name appears on the tournament roster. Expulsion will be immediate. Pets (other than service animals) and weapons of any kind will NOT be allowed in the event.

Athletic Trainers


Athletic Trainers will be available inside of McCormick Place.
